Pirate's Cove Splashpad Rules for Groups

- All groups need to have a permit to use the splashpad.
- Permit fee: \$3 per child. Staff are free. Valid for 3 hour time period. (9:30am-12:30pm, 12:30pm-3:30pm, 3:30pm-6:30pm. Splashpad is usually open from 10am-7pm, seven days a week, from Memorial Day to Labor Day.
- Use of the facility is at your own risk
- We are not responsible for loss or damage to personal property
- Splashpad may need to close periodically for maintenance/repairs.
- Splashpad Attendant will have wristbands for each group.
- Limited to 50 children from the group at a time on the splashpad (Children may alternate between Mount Playmore Playground and the Pirates Cove Splashpad.
- We prefer a staff to child ratio of 1:5 for supervision.
- Everyone needs to use the park restrooms or portable toilet. No diaper changing on the splashpad.
- Everyone needs to follow the rules for the splashpad and follow the directions given by the Attendant.
- No ill patrons – including inflamed eyes, nasal discharge, communicable diseases, any signs of diarrhea, stomach illness within the last 7 days. No open wounds, cuts, excessive sunburn
- Appropriate water attire is required for this family venue
- Infants and toddlers must wear swim diapers unless properly toilet trained
- Smooth bottom or rubber soled water shoes or bare feet are allowed
- The Splashpad attendant is not a lifeguard, but is there to answer questions, enforce basic rules and perform maintenance responsibilities.
- No climbing or hanging on fences or water features, no skateboards, skates, bicycles or hoverboards
- No unsafe play, inappropriate language or disruptive behavior
- No radios or amplified devices. No pets, no water toys
- No food, beverages, gum, glass containers, tobacco
- No candy, juice boxes, other foods or drinks are allowed on the splashpad. (food spills attract ants and cockroaches, small paper litter clogs the strainers, clogging water flow for the spray elements). There are picnic tables outside the splashpad.
- You may bring your own chairs for the staff, but they must stay under the pergola area, if there is room. No strollers, toys, chairs or other obstructions can be in the water play zone.
- The splashpad spray features shut down when the Lightning Detector Alarm sounds – when lightning is 10 miles away. Everyone needs to seek safe shelter (not restrooms, trees or metal gazebo) immediately, until the system sounds the All Clear siren, 30 minutes after the last lightning incident is detected.

Violators of the rules and regulations may be removed from the Splashpad
